## **Public Safety and Fiscal Management**

Committee Vote: Favorable 5-0 (In Favor: Councilmembers Exum, Harrison, Campos, Dean, and Turner)

This bill will approve the transfer of appropriations in the amount of \$1,055,000 from the Board of Education's Laurel High Auditorium and Classroom Addition Project (AA779825) (See Schedule A) to the following projects:

- 1. \$855,000 to Fairwood Elementary School (AA779773) (see Schedule B)
- 2. \$200,000 to Crossland High School Auditorium (AA770893) (see Schedule C)

The Office of Law has reviewed this bill and finds it to be in proper legislative form with no legal impediments to its enactment.

The enactment of CB-21-2010 will not have a negative fiscal impact on the County. The proposed transfer will move already appropriated funds from one project to another project without increasing the County expenditures.
