CB-18-2013 May 7, 2013

Committee Vote: Favorable 3-0 (In favor: Council Members Davis, Campos and Olson/Absent: Toles and Turner).

Staff provided a summary of the bill and referral comments that were received. CB-18-2013 amends several provisions of the County Code to transfer responsibilities and functions to the new Department of Permitting, Inspections and Enforcement (DPIE), created by CB-69-2012 and added as Section 17 to the Schedule of Legislation.

Dr. Haitham Hijazi, Director, and Susan Hubbard, Public Information Director, of the Department of Public Works and Transportation (DPWT) and Adam Ortiz, Acting Director, Gary Cunningham, Deputy Director, of the Department of Environmental Resources (DER) spoke in favor of the transfer of responsibilities from their respective departments into DPIE.

According to the Office of Audits and Investigations adopting CB-18-2013 will not have an adverse fiscal impact on Prince George's County.

The Office of Law finds CB-18-2013 to be in proper legislative form.

This legislation amends several provisions of the County Code to transfer certain responsibilities and functions to the Department of Permitting, Inspections, and Enforcement.

10/1/2013 - Prior to enactment CB-18-2013 was amended as follows:

1. On page 2, line 21, strike "DIVISION 21. TOWING REGULATIONS."
2. On page 2, line 22, strike "Sections 5-264, and 5-268"

CB-18-2013 (DR-2) was subsequently enacted.
