1 A RESOLUTION concerning

2 Housing and Community Development

3 Neighborhood Stabilization Program Amendments

4 For the purpose of approving a revised administration budget and staffing plan for the  
5 Neighborhood Stabilization Program (“NSP”).6 WHEREAS, Title III of Division B of the Housing and Economic Recovery Act of 2008,  
7 Pub. L. No. 110-289, §§ 2301-2305, 122 Stat. 2654, 2850-2854 (2008) (hereinafter “Title III of  
8 HERA”) appropriated \$3.92 billion for assistance to states and units of local government as  
9 emergency assistance for redevelopment of abandoned and foreclosed homes and residential  
10 properties; and11 WHEREAS, Title III of HERA provides that the NSP funding appropriated to the County  
12 shall be treated as Community Development Block Grant funds, except as required otherwise by  
13 Title III or alternative requirements issued by the Secretary of the U.S. Department of Housing  
14 and Urban Development (“HUD”); and

15 WHEREAS, the County has been allocated \$10,883,234 in NSP funding; and

16 WHEREAS, on March 24, 2009, HUD approved the NSP Substantial Amendment to  
17 Annual Action Plan: FY 2009 allowing the Prince George’s County Department of Housing and  
18 Community Development (“DHCD”) to use NSP funds for eligible costs associated with down  
19 payment and closing cost assistance, acquisition, rehabilitation, housing counseling, planning,  
20 and administration in the amount of \$10,883,234; and21 WHEREAS, DHCD, in order to adequately staff the NSP initiative, seeks (i) to revise the  
22 NSP planning and administration budget approved in the NSP Substantial Amendment to

1 \$1,088,323; and (ii) to amend the NSP staffing plan, as set forth in Attachment "A".

2 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
3 County that the NSP planning and administration budget and NSP staffing plan, as set forth in  
4 Attachment "A", are hereby approved.

5 BE IT FURTHER RESOLVED that the County Executive or his designee is hereby  
6 authorized to amend the NSP Substantial Amendment accordingly, submit changes to HUD, and  
7 to provide such additional information to HUD as may be required.
