**RESOLUTION**

1 A RESOLUTION concerning  
2 Maryland-National Capital Park and Planning Commission – Prince George’s County Members -  
3 Appointment and Geographic Balance

4 For the purpose of addressing the geographic distribution and balance of the membership of the  
5 Maryland-National Capital Park and Planning Commission and confirming A. Shuanise  
6 Washington as a member.

7 WHEREAS, Section 2-101 of Article 28 of the Annotated Code of Maryland requires that,  
8 in making and approving appointments to the Maryland-National Capital Park and Planning  
9 Commission, the County Council and County Executive shall attempt to provide reasonable  
10 geographic balance with respect to the places of residence of the members; and

11 WHEREAS, Section 2-101 of Article 28 of the Annotated Code of Maryland further  
12 requires that the appointment resolution for each appointment shall describe the resulting  
13 geographic distribution and provide appropriate explanations; and

14 WHEREAS, the County Executive has duly nominated A. Shuanise Washington, a resident  
15 of Mitchellville, to replace Sylvester J. Vaughns, a resident of Palmer Park, whose term has  
16 expired; and

17 WHEREAS, a public hearing on the nomination and confirmation of A. Shuanise  
18 Washington has been held; and

19 WHEREAS, the remaining four members of the Commission from Prince George’s County  
20 are residents of Temple Hills, Glenn Dale, Fort Washington, and Riverdale respectively.

21 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
22 County, Maryland, that, with the appointment of A. Shuanise Washington to the Maryland-

1 National Capital Park and Planning Commission, there continues to be reasonable geographic  
2 distribution with respect to the places of residence of the members of the Commission from  
3 Prince George’s County.

4 BE IT FURTHER RESOLVED that A. Shuanise Washington is hereby confirmed as a  
5 member of the Maryland-National Capital Park and Planning Commission, replacing Sylvester J.  
6 Vaughns, with a term expiring June 15, 2012.
