RESOLUTION

1 A RESOLUTION concerning

2 National Public Works Week 2021

3 For the purpose of expressing Prince George’s support for declaring the week of May 16 - 22,
4 2021 as National Public Works Week in Prince George’s County.

5 WHEREAS, public works professionals focus on infrastructure, facilities and services that
6 are of vital importance to sustainable and resilient communities and to the public health, high
7 quality of life and well-being of the people of Prince George’s County; and,

8 WHEREAS, these infrastructure, facilities and services could not be provided without the
9 dedicated efforts of public works professionals, who are engineers, managers and employees at
10 all levels of government and the private sector, who are responsible for building, improving and
11 protecting our nation’s transportation, water supply, water treatment and solid waste systems,
12 public buildings, and other structures and facilities essential for our residents; and,

13 WHEREAS, it is in the public interest for the residents, civic leaders and children in Prince
14 George’s County to gain knowledge of and to maintain a progressive interest and understanding
15 of the importance of public works and public works programs in their respective communities;
16 and,

17 WHEREAS, the year 2021 marks the 61st annual National Public Works Week sponsored
18 by the American Public Works Association / Canadian Public Works Association be it now; and

19 WHEREAS, Prince George’s County salutes the men and women of the Department of
20 Public Works and Transportation for continuing to provide these critical services without
21 interruption during the ongoing COVID-19 Pandemic.
