Committee Vote: Favorable with amendments, 8-0 (In favor: Council Members Lehman, Olson, Davis, Patterson Toles, Campos, Harrison, and Franklin)

CR-39-2012 amends the Prince Georges County FY 2009 Annual Action Plan to reprogram, restructure and approve funding for the Community Development Block Grant Recovery (CDBG_R) and the Homelessness Prevention and Rapid Re-Housing Program (HPRP) funds for existing activities. Funds in the amount of \$23,349.62 that was to be reprogrammed from Seat Pleasant CDC to the Laurel Boys and Girls Club, was amended to be reprogrammed to Bowie Road Improvement Project, City of Laurel. This amendment is reflected on Attachment A-1, Draft 2.

The Committee reviewed the reprogramming of these funds. Staff oriented the Committee on the comment period

and the corresponding supporting resolutions. DHCD Director Eric Brown, and CPD Administrator Shirley Grant provided comments and answered questions by the members of the Committee regarding the reprogramming process.

The Office of Law finds the CR-39-2012 is in proper legislative form and saw no legal impediments to its adoption.

The Office of Audits & Investigations found that enactment of CR-39-2012 will not have a negative or adverse fiscal impact on the County since it deals with federal funds.

This resolution will amend the FY 2009 Housing and Community Development Annual Action Plan to restructure, reprogram and approve existing and new CDBG-R and HPRP funds. This resolution requires a minimum of one public hearing under the "County Citizen Participation Plan FY 2011-2015," because it changes the use of CDBG-R and HPRP funds from one activity to another and approves funding for existing activities.
