Dear Mr. Donahue:

This joint signature letter endorses the Prince George's County Board of Education's proposed FY2024 capital budget request and identifies the projects that this County considers most critical. This funding endorsement is consistent with the County's priorities – construction funding for projects that have received State planning approval, approval of planning and construction funding requests for one modernization project, and the remaining construction funding for one (1) systemic replacement projects.

The Board's FY2024 State funding request of \$63 million focuses on major school modernization projects with one HVAC systemic project request. It reflects the advancement of a comprehensive modernization program aligned with the FY2023 Amendments to the FY2022 Educational Facilities Master Plan (EFMP). All other projects will be addressed through local funding.

The first priority is for continued State funding for those multi-year, major projects that have received State planning approval and prior year construction funding. These projects include:

The second priority addresses the expansion of the Cool Spring ES/Annex-Judith Hoyer Center Modernization/replacement Campus project which requires both planning approval and is in need of State construction funding. The project is essential to the start of the New Northern Area High School project, which will relieve overcrowding in several northern county high schools.
