#### **Public Safety and Fiscal Management**

Committee Vote: Favorable 4-0 (In Favor: Councilmember's Exum, Knotts, Bland, and Turner)

This resolution will provide supplemental appropriations of Federal, State and other funds in the amount of \$13,100,052 for FY2009. The additional appropriation will support grant efforts for the following eight (8) County agencies and the Circuit Court:

- 1. Health Department \$ 1,696,349
- 2. Fire/EMS Department \$ 930,000
- 3. Circuit Court \$ 3,000
- 4. Police Department \$ 15,416
- 5. Office of Homeland Security \$ 900,000
- 6. Department of Housing and Community Development-\$2,243,373
- 7. Department of Family Services \$ 302,939

- 8. Department of Social Services \$ 108,975
- 9. Department of Public Works and Transportation -\$6,900,000

An additional \$15,622 in County General Funds is included in the total amount appropriated. This County match funds will enable the Department of Family Services to expand the Senior Training and Employment Program.

Included in the amount of \$2,243,373 received by the Department of Housing and Community Development is the recently awarded amount of \$2,000,000 from the State of Maryland for the Neighborhood Conservation Initiative (NCI) which will provide additional funding for the County's Neighborhood Stabilization Program (NSP).

The adoption of CR-39-2009 will not have a negative fiscal impact on the County
