BILL

AN ACT concerning

An Interproject Transfer of Appropriations and the
Reestablishment of a previously approved Capital Project
in the FY1991-1992 Capital Budget.

FOR the purpose of transferring appropriations between capital
projects in the amount of \$312,000 from the Contingency Fund to
Woodmore Road.

WHEREAS, pursuant to the provisions of Section 818 of the
Charter for Prince George's County, Maryland, the County Council may
authorize, by legislative act, upon request of the County Executive,
interproject transfers of appropriations between capital projects in
the Approved Capital Budget; and

WHEREAS, the County Executive deems it desirable to provide
additional appropriations for Woodmore Road (FD666551) as currently

existing appropriations are inadequate for project completion; and

WHEREAS, the County Executive recommends that appropriations
c

an be transferred from the Contingency Fund, as an excess of
appropriations over estimated costs is expected; and

WHEREAS, the use of bond proceeds for the purpose set forth
herein is in full compliance with all applicable County laws,
including all appropriate bond enabling and bond authorization acts;
now, therefore

SECTION 1. BE IT ENACTED by the County Council of Prince
George's County, Maryland, that Woodmore Road, CIP# FD 666551, is
hereby reestablished as a capital project in the FY1992 Capital
Budget.

SECTION 2. BE IT FURTHER ENACTED that the Fiscal Year 1992
Approved Capital Budget is hereby amended, as shown on Attachments A
and B, attached hereto, to provide that appropriations are
transferred as follows:
