### **ZONING BILL**

AN ORDINANCE concerning

Industrial Zones

For the purpose of prohibiting the construction of churches in the Industrial Zones in the Route 202 Corridor Study Area unless constructed pursuant to a Conceptual Site Plan approved by the Planning Board prior to June 1, 1997. BY repealing and reenacting with amendments:

> Section 27-473, The Zoning Ordinance of Prince George's County, Maryland, being also SUBTITLE 27. ZONING.

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that Section 27-473 of the Zoning Ordinance of Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code, be and the same is hereby repealed and reenacted with the following amendments:
