**A resolution of support for establishment of a State Arts and Entertainment District**

**Whereas**, a State Arts and Entertainment District has been proposed for part of Mount Rainier and of its neighboring municipalities of Brentwood, North Brentwood, and Hyattsville; and

**Whereas**, a State Arts and Entertainment District would be a valuable tool for the promotion of economic development, new business, and expanded employment opportunities in Mount Rainier, and thereby expand the City's very limited business community and commercial tax base; and

**Whereas**, a State Arts and Entertainment District would provide income, property, and admissions and amusement tax incentives that could help attract new arts-related businesses, as well as artists and other new residents attracted to live in the District, and could enrich the cultural life of the City; and

**Now, therefore**, be it resolved by the Mayor and City Council that the City of Mount Rainier strongly supports the establishment of a State Arts and Entertainment District encompassing parts of Mount Rainier, Brentwood, North Brentwood, and Hyattsville, urgently requests the support of its elected officials, and pledges its continuing and full support to the implementation of revitalization initiatives within this District.





**WHEREAS**, a State Arts and Entertainment District is a tool for local government to promote economic development; and




