**BILL**

AN ACT concerning

Collective Bargaining Agreement - Council 67,  
American Federation of State, County and Municipal Employees,  
AFL-CIO, and its affiliated Local 2462

(Fire Department Bureau of Apparatus Maintenance Unit).

FOR the purpose of approving a labor agreement by and between Prince George's County and Council 67, American Federation of State, County and Municipal Employees, AFL-CIO, and its affiliated Local 2462 covering employees in the Fire Department Bureau of Apparatus Maintenance Unit, to provide for wage increases and certain other terms and conditions of employment for personnel classifications certified by the Prince George's County Public Employee Relations Board.

BY repealing and reenacting with amendments:

SUBTITLE 16. PERSONNEL.

Section 16-233(f),

The Prince George's County Code  
(1987 Edition, 1988 Supplement).

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that Section 16-233(f) of the Prince George's County Code be and the same is hereby repealed and reenacted with the following amendments:

**SUBTITLE 16. PERSONNEL.**

**DIVISION 19. COLLECTIVE BARGAINING.**

**Sec. 16-233. General.**

(f) The following collective bargaining agreements are hereby adopted and approved:

(17) Declaration of Approval - Local 2462, American Federation of State, County and Municipal Employees, AFL-CIO (Fire Department Bureau of Apparatus Maintenance Unit).

The County Council of Prince George's County, Maryland, having fully considered the labor agreement concluded between Prince George's County and Council 67, American Federation of State, County and Municipal Employees, AFL-CIO, and affiliated Local 2462, on May 21, 1990, hereby approves said agreement in accordance with the provisions of Section 13A-109 of the Prince George's County Code.

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after the date it becomes law and that the provisions of the labor agreement shall be retroactively effective to the date specified in the agreement.
