It is my pleasure to submit to you and the County Council the appointment of Ms. Alicia A. Doney and Ms. Michelle L. Rice to the Redevelopment Authority Board of Prince George's County. The Redevelopment Authority Board acquires land and property within Prince George's County for residential, commercial or industrial development or redevelopment, and for the revitalization of the County's older communities.

She is actively involved on boards of various industry, local civic, community and charitable organizations. Ms. Rice received her undergraduate degree from Temple University and a graduate degree from the University of Southern California.

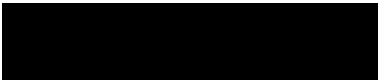
