## **BILL**

## AN ACT concerning

Supplementary Appropriations in the Approved Fiscal Year 2012 Capital Budget For the purpose of providing a supplementary appropriation to the County Building Renovations 2 capital project in the amount of \$8,021,600 and amending the Approved Fiscal Year 2012-2017 Capital Improvement Program with regard to expenditures and financing beyond the budget year.

WHEREAS, the Charter of Prince George's County, Maryland provides for the adoption of the County budget, which includes the capital budget and capital improvement program; and

WHEREAS, pursuant to CB-24-2011, the County Budget, known as the Annual Budget and Appropriation Ordinance of Prince George's County for Fiscal Year 2012, which includes the Fiscal Year 2012-2017 Capital Improvement Program - Fiscal Year 2012 Capital Budget was adopted; and

WHEREAS, the Approved Fiscal Year 2012-2017 Capital Improvement Program sets forth the plan of the County to receive and expend funds for capital projects during the fiscal year covered by the capital budget and the next succeeding five fiscal years thereafter and also the means of financing said projects; and

WHEREAS, pursuant to Section 815 of the Charter for Prince George's County, Maryland, the County Council, upon recommendation of the County Executive, may, by Legislative Act, make additional or supplementary appropriations from revenue received from anticipated sources but in excess of budget estimates therefor; and

WHEREAS, additional unanticipated revenues have been received; and

WHEREAS, the County Executive deems it desirable to provide additional appropriations 1 | 2 for the County Building Renovations 2 capital project (SQ300123) as currently existing 3 appropriations are inadequate; and 4 WHEREAS, pursuant to Sections 815 and 820 of the Charter, the County Executive 5 recommends that these supplementary appropriation be made. 6 SECTION 1. BE IT ENACTED by the County Council of Prince George's County, 7 Maryland, that the Fiscal Year 2012 Approved Capital Budget is hereby amended, as shown on 8 Schedule A attached hereto and made a part hereof, to provide supplementary appropriations as 9 follows: 10 Orig. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) 21 calendar days after it becomes law, and shall be retroactively effective to June 30, 2012.
