RESOLUTION

1 A RESOLUTION concerning

2 Fire Prevention Code

3 For the purpose of adopting individual codes and standards of the National Fire Protection
4 Association in accordance with Section 11-253 of the County Code.

5 WHEREAS, Section 11-253 of the Prince George's County Code identifies various codes
6 and standards of the National Fire Protection Association to be adopted by resolution; and

7 WHEREAS, the adopted Standards of the National Fire Protection Association form an
8 integral part of the Building, Mechanical and Electrical Codes of the County.

9 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
10 County, Maryland, that the following enumerated codes, standards and model laws published
11 by the National Fire Protection Association are hereby adopted and made a part of Subtitle 11,
12 Division 4 of the Prince George's County Code in their entirety. The text of these adopted
13 codes, standards and model laws shall be fully enforceable as if the same were incorporated and
14 set forth at length therein. If any provision of the codes, standards, and model laws adopted
15 herein, is less restrictive than the provisions of Subtitle 4 of the County Code, then the
16 conflicting provision of the following codes, standards, or model laws shall not apply. The
17 current edition of the individual codes and standards shall be indicated by the date or edition
18 listed.
