This resolution amends the Fiscal Year 2026 Operating Budget for the Recreation Fund of the Maryland-National Capital Park and Planning

Commission (M-NCPPC). Within the adopted budget for the Recreation Fund, the County Council set aside funding (project charges) for identified community organizations carrying out recreation programming with the County. Since the adoption of the budget (CB-055-2025) in May 2025, the Council has identified additional opportunities to expand programming within funded organizations. Pursuant to its authority under the Land Use Article of the Annotated Code of Maryland, the Council amended the budget through CR-130-2025 and CR-001-2026 to reallocate funding among project charges to take advantage of these programming opportunities. This resolution proposes to reallocate \$190,000 of funding to the University of Maryland Cooperative Extension Service (\$160,000), End Time Harvest Ministries (\$20,000) and Woodlawn Civic Association (\$5,000).
