BILL

1 AN ACT concerning

2 Collective Bargaining Agreement –

3 Deputy Sheriff's Association of Prince George's County, Inc.

4 For the purpose of amending the labor agreement by and between Prince George's County,
 5 Maryland ("County") and the Deputy Sheriff's Association of Prince George's County, Inc.
 6 ("DSA"), covering July 1, 2005 through June 30, 2007, by amending Salary Schedule W for the
 7 position of Deputy Sheriff Private (W21).

8 WHEREAS, the County and the DSA, in negotiating the terms of the labor agreement
 9 adopted pursuant to CB-7-2006, agreed to reopen negotiations to amend Salary Schedule W for
 10 the position of Deputy Sheriff Private (W21), effective July 9, 2006; and

11 WHEREAS, the County and DSA, having concluded those negotiations, on September 14,
 12 2006 entered into a Settlement Agreement, attached hereto and incorporated herein as
 13 Attachment A, modifying the labor agreement to reflect the amendments to Salary Schedule W.

14 BY repealing and reenacting with amendments:

15 SUBTITLE 16. PERSONNEL.

16 Section 16-233(f)(14),

17 The Prince George's County Code

18 (2003 Edition, 2005 Supplement).

19 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
 20 Maryland, that Section 16-233 (f)(14) of the Prince George's County Code be and the same is
 21 hereby repealed and reenacted with the following amendments:

SUBTITLE 16. PERSONNEL.

DIVISION 19. COLLECTIVE BARGAINING.

Sec. 16-233. General.

* * * * *

(f) The following collective bargaining agreements are hereby adopted and approved:

(14) Declaration of Approval - Deputy Sheriff's Association of Prince George's County, Inc. (Deputy Sheriffs).

The County Council of Prince George's County, Maryland, having fully considered the labor agreement concluded between Prince George's County, Maryland and the Deputy Sheriff's Association of Prince George's County, Inc., on January 17, 2006, and as amended on September 14, 2006, hereby approves said agreement in accordance with the provisions of Section 13A-109 of the Prince George's County Code.

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law and shall be retroactively effective to July 9, 2006.
