BACKGROUND INFORMATION/FISCAL IMPACT:

Prince George's County, Maryland and the Deputy Sheriff's Association of Prince George's County, Inc. (Civilian Units) have completed labor negotiations on a one-year labor agreement covering Fiscal Year 2016. This bill is to adopt and approve the referenced collective bargaining agreement in accordance with Section 16-233(f) of the Personnel Law.
