**RESOLUTION**

1 A RESOLUTION concerning

2 Priority Preservation Area Functional Master Plan

3 For the purpose of approving the Adopted Priority Preservation Area Functional Master Plan,  
4 with Amendments.

5 WHEREAS, on July 13, 2010, the County Council of Prince George's County, Maryland,  
6 sitting as the District Council, directed The Maryland-National Capital Park and Planning  
7 Commission to initiate preparation of a Priority Preservation Area Functional Master Plan in  
8 order to satisfy the requirements of HB 2 2006, Section 3.05(a)(6)(ii)(8) of Article 66B in  
9 accordance with Section 2-518 of the Agricultural Article of the Annotated Code of Maryland  
10 that all Maryland counties intending to have a certified agricultural land preservation program  
11 prepare and adopt a Priority Preservation Area Element (PPA) in their comprehensive plans  
12 and to ensure that future development is consistent with County Policies and the endorsed  
13 goals, concepts and guidelines prepared by the Planning Board pursuant to Section 27-643 of  
14 the Zoning Ordinance; and

15 WHEREAS, the Prince George's County Planning Board granted permission to print the  
16 Preliminary Priority Preservation Area Functional Master Plan on June 2, 2011; and

17 WHEREAS, the District Council and the Planning Board held two duly-advertised joint  
18 public hearings on the Preliminary Priority Preservation Area Functional Master Plan on  
19 September 13, 2011, and January 24, 2012; and

20 WHEREAS, the Preliminary Priority Preservation Area Functional Master Plan is  
21 proposed to amend the 2002 *Prince George's County Approved General Plan*; 2010 *Approved*  
22 *Water Resources Functional Master Plan*; 2010 *Approved Historic Sites and District Plan*;

31 WHEREAS, the Planning Board held a work session to consider the public hearing

1 testimony on March 29, 2012; and

2 WHEREAS, on April 12, 2012, the Planning Board, in consideration of the public  
 3 hearing testimony, adopted the master plan with revisions, as described in Prince George’s  
 4 County Planning Board Resolution PGCPB No. 12-28, and transmitted the plan to the District  
 5 Council on May 11, 2012; and

6 WHEREAS, the District Council held work sessions on June 18, 2012, to consider  
 7 hearing testimony; and

8 WHEREAS, upon consideration of the testimony received through the hearing process,  
 9 the District Council determined that the adopted plan should be approved as the priority  
 10 preservation area functional master plan for Prince George's County, Maryland, and  
 11 recommended additional revisions set forth herein.

12 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
 13 County, Maryland, sitting as the District Council for that part of the Maryland-Washington  
 14 Regional District in Prince George's County, Maryland, that the Adopted Prince George’s  
 15 County Priority Preservation Area Functional Master Plan be and the same is hereby approved
