## LEGISLATIVE HISTORY

HOUSING AND ECONOMIC DEVELOPMENT COMMITTEE REPORT DATE: July 11, 1990

Committee Vote: Favorable, as amended, 2-1-0 (In favor: Council Members Pemberton and Casula; Opposed: Council Member MacKinnon)

Mr. Gerard McDonough representing the applicant was present for the worksession. This category change request was initiated by the Council and introduced on June 26, 1990. The County Executive in his letter to the Chairman dated July 10, 1990 recommended retaining the property in Category 6 due to several environmental factors: steep slopes, wetlands, on-going SHA grading, proposed density and access. During the worksession, the Executive's staff suggested referring this case to the next cycle. CR-67-1990 (DR-3) - Summary

The Committee reviewed the development proposed and voted in favor of Category 4C subject to the applicant submitting to the M-NCPPC a preliminary plan.

## BACKGROUND INFORMATION/FISCAL IMPACT

LOCATION: The County Comprehensive Ten Year Water and Sewer Plan provides for three cycles of category change requests to amend the Plan. This resolution is a special amendment outside the regular cycle amendments, and approves the water and sewer category change for Patuxent Downs in Western Branch Basin.

The 1988 Ten Year Water and Sewerage Plan was adopted by CR-17-1988, and amended by CR-12-1988, CR-67-1988, CR-103-1988, CR-27-1989, CR-60- 1989, CR-84-1989, CR-102-1989 and CR-14-1990. Environmental Article, Title 9, Subtitle 5 sets procedures for amendments and revisions to the Plan. At least 30 days prior to the public hearing on the amendments, the County Council must submit to the WSSC and M-NCPPC a copy of the proposed resolution for their recommendations.
