RESOLUTION

A RESOLUTION concerning

The Sale on a Consolidated Basis of Stormwater Management Bonds

For the purpose of authorizing and empowering Prince George's County, Maryland, to
consolidate for sale and issue, sell and deliver, as part of a single issue of bonds, an amount not
to exceed Seven Million One Hundred Twenty-five Thousand Dollars (\$7,125,000) in aggregate
principal amount of stormwater management bonds previously authorized by enactment of
CB-94-1998, CB-71-1999, and CB-52-2000 with the sale and issuance by Prince George's
County, Maryland of its General Obligation Consolidated Public Improvement Bonds, Series
2001.

WHEREAS, Section 2C of Article 31, Annotated Code of Maryland (1997 Replacement Volume, 2001 Supplement) (as amended from time to time) permits the County Council to provide by resolution that bonds authorized to be sold by separate acts of legislation be consolidated for sale and issued, sold and delivered as a single issue of bonds; and

WHEREAS, the County Council, pursuant to Article 29, Annotated Code of Maryland (1997 Replacement Volume, 2001 Supplement) enacted CB-94-1998, CB-71-1999 and CB-52-2000, that authorized the issuance and sale of \$8,875,000, \$6,756,000 and \$5,646,000, respectively, of stormwater management bonds (the "Bonds"); and

WHEREAS, Prince George's County, Maryland is preparing to sell and issue its General Obligation Consolidated Public Improvements Bonds, Series 2001 and intends to consolidate for sale and issuance as part of the sale and issuance of the Prince George's County, Maryland General Obligation Consolidated Public Improvement Bonds, Series 2001, the Bonds authorized by CB-94-1998, CB-71-1999 and CB-52-2000.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Prince George's County, Maryland that the County Council hereby authorizes that the Bonds (or any portion of them) may be consolidated for sale and issued, sold and delivered as a single issue of Bonds or as two or more issues of Bonds, or may be consolidated with other bonds of the County, as authorized by Section 2C of Article 31 of the Annotated Code of Maryland, as amended, replaced, or recodified from time to time. Such bonds shall each be designated "Prince George's County, Maryland Consolidated Public Improvement Bonds, Series 20___," shall be in form appropriate to consolidation and, in the event such bonds are issued at more than one time, the County Executive or, if so provided by order of the County Executive, the Chief Administrative Officer, by order, may specify such additional designation as he or she shall deem appropriate. Moreover, the County Executive or, if so provided by order of the County Executive, the Chief Administrative Officer, is hereby authorized to provide such other or alternative designation as he or she deems necessary or convenient to indicate the year of issuance of the Consolidated Public Improvement Bonds.
