A RESOLUTION concerning

Electric Permit Fees

For the purpose of establishing a schedule of permit fees for electrical permits.

WHEREAS, Section 9-121 of the Prince George's County Code provides that permit fees for electrical permits shall be proposed by the County Executive and adopted by the County Council by resolution; and

WHEREAS, the County Executive has proposed permit fees for electrical permits as proposed amendments to Section 9-121 contained in CB-23-1996 (DR-1) which were revised to reflect the actual cost for performing electrical permit inspections.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the electrical permit fees included herein be and the same are hereby approved in accordance with the provisions of Section 9-121 of the Prince George's County Code.

**RESIDENTIAL AND COMMERCIAL FEES**

NOTE: Reference to "residential" in this schedule means one- and two- family dwellings, townhouses, and individual dwelling units within mid-rise and high-rise apartments.

Special Service and/or Conditions not provided for in this schedule: The rate of fee for special services not set out in this fee schedule shall be determined by an hourly rate of \$60.00 (with a one

hour minimum).

Investigation fee for reporting of work performed without proper license and/or work performed without a permit:

Commercial	\$200.00
Residential	\$100.00

BE IT FURTHER RESOLVED that the permit fees adopted by this resolution shall be effective on the effective date of Council Bill CB-23-1996.
