Chairman Davis offered introductory remarks and welcomed Dr. Joseph Wright and the representatives from the Health Department and Department of Social Services and also the Chief of Police.

Dr. Joseph Wright provided opening remarks regarding the purpose for this evening's briefing. He introduced Dr. Ernest Carter, Deputy Health Officer who expressed his regrets that Dr. Pamela Creekmur, Health Officer, could not be present at this meeting.

Dr. Jacqueline Duval-Harvey began the power point presentation with providing a summary of the baseline data, overdose prevention by program, overdose fatality review and the County's overdose data. Council members were presented with a "data by district" handout. Dr. Duval Harvey also spoke regarding the Maryland Opioid Operational Command Center. Ms. Donna Perkins spoke to the numbers as they relate to opioid related deaths in the County, Fire/EMS Naloxone Use as well as Naloxone training provided in the County. Chief Stawinski spoke to the opioid issue as it impacts the Police Department. Stephen Liggett-Creel explained the role the Department of

Social Services plays with regard to substance abuse in the County. He stated that it is not the substance abuse itself, but the resulting affects on the welfare of children in the home. The panelists responded to many questions posed by Council Members. Dr. Betty Braswell and Mr. Ron Bates also responded to Council Member questions.
