BACKGROUND INFORMATION/FISCAL IMPACT:

This Resolution will add two capital projects, provide supplementary appropriations and amend the Fiscal Year 2016-2021 Capital Improvement Program of the Redevelopment Authority of Prince George's County. The Redevelopment Authority received a total of \$725,000 in State grants to support various capital projects. The State grant funds will support the County Revitalization (UM900995) project in the amount of \$225,000, Gateway Arts District (UM900013) project in the amount of \$250,000 and the Addison Road/Capitol Heights Metro (UM900063) project in the amount of \$250,000.
