AN ACT concerning

A Supplementary Appropriation

FOR the purpose of providing funding from prior year available and uncommitted fund balance to the Non-Departmental Grants and Transfers section of the County Budget.

WHEREAS, Council Bill CB-91-1989, as amended, adopted and enacted the Annual Budget and Appropriation Ordinance of Prince George's County for Fiscal Year 1989-1990, which sets forth the amount of appropriations and revenue estimates, said appropriations and revenue estimates to be adjusted as hereinafter set forth; and

WHEREAS, under the provisions of

Section 819 of the Charter for

Prince George's County, Maryland, the County Council, upon recommendation of the County Executive, may make additional or supplementary appropriations from any prior year available and uncommitted fund balance; and

WHEREAS, the Association for Retarded Citizens of Prince

WHEREAS, the County Executive has duly recommended the additional appropriation; and

WHEREAS, the Director of Finance has certified in writing that funds are available for such supplementary appropriation; now, therefore,

SECTION 1. BE IT ENACTED by the County Council of Prince
