RESOLUTION

1 A RESOLUTION concerning

2 Special Event Expedited Review Fee

3 For the purpose of adopting a new Special Event Expedited Review Fee to expedite the review
 4 and approval of Special Event Temporary Use and Occupancy Permit applications. The Special
 5 Event Expedited Review Fee will be assessed on a graduated basis to cover the administrative
 6 costs for an expedited plan review and inspection for the issuance of a Special Event Temporary
 7 Use and Occupancy Permit.

8 WHEREAS, Special Event Expedited Review Fees are needed to cover the increased
 9 administrative costs for the plan review and inspections needed to approve a Special Event
 10 Permit when applications are submitted outside of the required timeframe needed to review and
 11 approve Special Event Permits; and

12 WHEREAS, the proposed graduated expedited fee will cover the Department of Permitting,
 13 Inspections and Enforcement (“DPIE”) costs of overtime for plan review and inspections, or On-
 14 Call plan review or inspection services contracted by DPIE ensuring a timely review of Special
 15 Event Permit applications; and

16 WHEREAS, the Special Event Expedited Fees shall be adopted and collected per the fee
 17 prescribed in the Table of Fees; and

18 WHEREAS, pursuant to Section 2-253.63 of the Prince George’s County Code, the DPIE
 19 shall establish and maintain a table of fees for all types of permits and such table shall be
 20 published on the DPIE website; and

21 WHEREAS, pursuant to Section 2-253.63 of the Prince George’s County Code, the

1 Director of DPIE or County Council shall have the authority to change the fees as deemed
2 necessary; and

3 WHEREAS, prior to changing the fees, DPIE must hold a public information session to
4 allow for public comment, must submit the fee changes to the County Executive for approval,
5 and then must submit the fee changes to County Council by Resolution for approval after notice
6 and a public hearing; and


7 WHEREAS, Attachment A is the proposed Table of Fees including the Special Event
8 Expedited Review Fee, attached hereto and made a part of the record hereof; and

9 WHEREAS, the County Executive reviewed such changes and approved the increase as
10 appropriate and necessary.

11 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
12 County, Maryland, that Special Event Expedited Review Fee, established, maintained, and
13 published by the Department of Permitting, Inspections and Enforcement as described in the
14 Table of Fees set forth in Attachment A attached hereto and made part of the record hereto of is
15 approved as appropriate and necessary.
