BACKGROUND INFORMATION/FISCAL IMPACT:

Sections 27-548.26 and 27-642 of the Zoning Ordinance of Prince George's County provide a process for initiation and approval of minor amendments to approved comprehensive plans by the District Council. This Resolution initiates a minor amendment in accordance with the local zoning laws to amend certain development district standards regulating specific building heights that were approved within the 2013 *Largo Town Center Sector Plan and Sectional Map Amendment*.
