Committee Vote: Favorable with amendments, 5-0 (In favor: Council Members Dean, Knotts, Bland, Dernoga and Olson)

Staff summarized the purpose of the legislation and informed the committee of referral comments that were received. CB-72-2010 adds and defines a new use entitled "University Research and Development Park" to the Zoning Ordinance and permits the use by right in the I-3 Zone. The bill also permits an eating or drinking establishment within a University Research and Development Park if the establishment is not freestanding. Lastly, CB-72-2010 permits research and development in the I-3 Zone where it is currently prohibited.

The Office of Law reviewed CB-72-2010 and determined that it is in proper legislative form with no legal impediments to its adoption. The Planning Board supports the legislation with amendments.

Thomas Haller, representing M-Square/Suit Property (University of Maryland Research Campus) and William Shipp, representing Howard University, spoke in support of CB-72-2010.

The committee voted favorably on the legislation with certain amendments recommended by the Planning Board as

follows:

- (1) On page 2, line 9, change "and" to "or".
- (2) On page 2, line 15, delete "private" and replace with "the", and add the words "but not limited to" behind the word "including".

The committee also voted to delete the word "campus" in the definition of a "University Research and Development Park".
