AN ACT concerning

Energy and Fuel Tax

FOR the purpose of increasing the rate of the energy and fuel tax.

BY repealing and reenacting with amendments:

SUBTITLE 10. FINANCE AND TAXATION.

Section 10-205.1,

## COLLECTION.

Subdivision 1B. Energy and Fuel Tax.

Sec. 10-205.1. Energy and fuel tax; computation; imposition; levy; collection; exceptions.

\* \* \* \* \*

- (i) For any fiscal year beginning after June 30, 1988, the rates of tax levied will be established in the following manner:
- (1) On or before the preceding February 1, each vendor shall certify to the Director the revenues and consumption for the prior calendar year.
- (2) The Director shall compute the proposed rates of taxation for the next fiscal year by multiplying the sums of the revenues for each classification of energy or fuel delineated in Subsection (h) by .05, and then dividing that product by the sums of consumption for each classification, which rates shall be included in the proposed operating budget submitted by the County Executive. Effective with the fiscal year beginning July 1, 1991, and thereafter, the multiplier herein shall increase from .05 to .075

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect on July 1, 1991.
