COMMITTEE OF THE WHOLE REPORT

Committee vote: Favorable as amended, 7-1, (In favor: Councilmembers Shapiro, Bland, Exum, Harrington, Hendershot, Knotts, and Peters. Opposed: Dernoga. Absent: Dean.

The Committee of the Whole of the Council discussed a number of resolutions submitted for approval pursuant to requirements set forth by the National Football League for Super Bowl XLII, (2008).

Date: 9/9/03

The County Executive stated that the participation of Prince George's County, Maryland in the Super Bowl, the largest national annual sporting event held in the United States, presents a profound and unique opportunity for County citizens and residents. Also, hosting the Super Bowl will generate goodwill, create numerous temporary jobs, provide beneficial economic activity and enhance the prestige and reputation of Prince George's County worldwide.

Some of the Council Members expressed their concerns with the financial cost the County would incur in hosting the Super Bowl. The County Executive's Chief of Staff stated that the Governor has assured them that the County will not suffer any economic loss as a result of hosting the Super Bowl.

Council Member Harrington suggested that a task force be appointed to examine the proposed economic impact of hosting the Super Bowl in Prince George's County.

All the resolutions were amended by deleting Washington, D. C. and inserting Prince George's County, Maryland as the designated site for Super Bowl XLII, (2008) and related official events.

BACKGROUND INFORMATION/FISCAL IMPACT

In conjunction with the Bid for Super Bowl XLII (2008), the National Football League requires that the governing body of Prince George's County, Maryland adopt a resolution for the purpose of providing fire and medical emergency services for Super Bowl XLII (2008). Prince George's County, Maryland reserves the right to enter into mutual aid agreements with the Host Committee and Federal, State and local governments and fire and medical emergency services agencies and any other public or private entities to provide the required fire and medical emergency services and to negotiate with the Host Committee and Federal, State and local governments and fire and medical emergency services agencies and any other public or private entities for the reimbursement of costs of providing required fire and medical emergency services. This Resolution shall take effect upon the date of adoption and the provisions of this Resolution shall take effect upon the date of receipt of a successful bid by the Washington, D.C. Super Bowl Host Committee for Super Bowl XLII (2008).
