**RESOLUTION**

1 A RESOLUTION concerning

2 The Revenue Authority of Prince George's County Fiscal Year 2025

3 Operating Budget and Capital Improvement Program

4 For the purpose of approving the Capital Improvement Program of the Revenue Authority of  
5 Prince George's County for Fiscal Years 2025-2030, prepared pursuant to the authority contained  
6 in Subtitle 21A of the Prince George's County Code and providing comments on the proposed  
7 Operating Budget of the Authority for Fiscal Year 2025.

8 WHEREAS, Section 21A-119 of the Prince George's County Code provides that the  
9 Revenue Authority of Prince George's County may propose one or more projects for inclusion in  
10 the Authority's Capital Improvement Program and that the County Executive shall transmit to the  
11 County Council for its approval by resolution or ordinance any such project approved by the  
12 County Executive; and

13 WHEREAS, the Capital Improvement Program for the Revenue Authority includes one  
14 construction project, one housing project, one new mixed-use development project, one  
15 rehabilitation parking project, and one new parking project. The Suitland Project (4.91.0003), the  
16 Hyattsville Justice Center Garage (4.91.0004), the University of Maryland (UM) Capital Region  
17 Medical Center Garage (4.91.0005), the Suitland Workforce Housing Building K Project  
18 (4.91.0006), and the Suitland Mixed Use – Building A&B (4.91.0007), are in the Program but  
19 not funded in Fiscal Year 2025. Project descriptions are included in the Capital Improvement  
20 Program for Fiscal Years 2025-2030 of the Revenue Authority, attached hereto as Attachment 1;  
21 and

1 WHEREAS, the Capital Budget for Fiscal Year 2025 equals Zero dollars (\$0); and

2 WHEREAS, Section 21A-118 of the Prince George's County Code provides that if the  
3 proposed operating budget of the Authority includes any item to be funded from payments to be  
4 received from the County that the anticipated receipts shall be identified for each item and a copy  
5 of the proposed budget shall be transmitted by the Authority to the County Executive and the  
6 County Council for their review and comment; and

7 WHEREAS, the Authority has forwarded its proposed operating budget to the County  
8 Executive and the County Council for review and comment, as shown in Attachment 2.

9 SECTION 1. BE IT THEREFORE RESOLVED by the County Council of Prince George's  
10 County, Maryland, that subject to and in accordance with the authority of the Charter of Prince  
11 George's County and pursuant to Subtitle 21A of the Prince George's County Code, the Capital  
12 Improvement Program for Fiscal Years 2025-2030 of the Revenue Authority of Prince George's  
13 County, as submitted by the County Executive to the County Council, a copy of which is  
14 attached hereto as Attachment 1 and incorporated herein by reference as though it was set forth  
15 fully herein, is hereby authorized, approved, and adopted.

16 SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the  
17 proposed Fiscal Year 2025 Operating Budget of the Revenue Authority of Prince George's  
18 County and concurs with the proposed Operating Budget for the Revenue Authority as reflected  
19 in Attachment 2.
