It is my pleasure to submit to you and the County Council the appointments of Mr. Isaac E. Esene, Ms. Caren A. Gillison, Ms. Shonda W. Harmon, Ms. Erin F. Kabba, Ms. Kayon R. This Commission works to eliminate discriminatory practices within Prince George's County through advocacy, education, mediation and investigation of complaints and enforcement of discrimination laws. The dedicated public service and expertise shown by these individuals will be an asset to the Commission, and I am pleased that they have agreed to serve.

Mr. Issac E. Esene, a resident of Upper Marlboro, is a military veteran, healthcare professional, and the executive director of a leading youth public safety program. He was awarded the Echoing Green Fellowship, globally recognized as a leading social innovator for advancing public safety and health equity initiatives. Mr. Esene previously served as a Political Advocacy Scholar with the American Academy of Physician Assistants (AAPA) and as a Program Manager, Safety and Government Liaison with the United States Air Force. He received his undergraduate degree from Towson University; his Master of Medical Sciences from Frostburg State University; and his Master of Business Administration from Georgetown University.

Gillison, a resident of Capitol Heights, is a public servant with Court Services & Offender Supervision Agency (CSOSA) where she oversees the selection and administration of screeners, assessments, and evaluations to identify offenders' criminogenic risks, needs, and stabilization requirements. She also serves in a dual role as CSOSA Adjunct Trainer and Community Supervision Officer. Ms. Gillison is Owner/Mental Health Therapist of InVigor Therapeutic Services, LLC. She received her undergraduate degree from Virginia Commonwealth University; her Master of Arts degree from Marymount University; and her second Master of Arts degree from the University of the District of Columbia.

Ms. Shonda W. Harmon, a resident of Upper Marlboro, is an experienced Practice Manager with a proven track record of successfully overseeing day-to-day operations and maximizing efficiency. She has been a Practice Manager and Co-Owner of Harmon Orthodontics, a multimillion-dollar practice since 1999. She worked in the corporate world as an Account Executive with Honeywell. She obtained her undergraduate degree from The Ohio State University and earned a Master of Science in Business Administration and a Master of Science in Public Administration from Cleveland State University.


