Committee Vote: Favorable 5-0 as amended (In Favor: Councilmember's Exum, Knotts, Bland, Campos and Turner)

This resolution will express a preference that any of the Federal Economic Renewal Grant funds provided to Prince George's County should be spent by the County on products and services that are made and performed in the United States of America.

The resolution was held in Committee on April 15, 2009 pending receipt of a copy of the resolution from the Maryland Senate and a letter from the House of Delegates. These items were received.

The legislation was amended by incorporating language from the resolution passed by the Senate.

The Office of Law has reviewed this resolution and finds it to be in proper legislative form with no legal impediments to its adoption.

The adoption of CR-12-2009 will not have a negative fiscal impact on the County
