| to residential or commercial zones for the purpose of preserving, improving and protecting the | |
| general character and design of lands within the corporate limits of the municipality, provided | |
| that such ordinances impose stricter or additional limitations or restrictions than are otherwise | |
| imposed by the C | County zoning regulations; and |
| WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code provides that | |
| such ordinance shall not be effective until approved by the County Council of Prince George's | |
| County, sitting as the District Council; and | |

WHEREAS, the City of Bowie, pursuant to Section 8-112.1 of Article 28 of the Maryland

Annotated Code, has delivered a certified copy of the Ordinance to the District Council; and

1 WHEREAS, the District Council has determined that the Ordinance imposes additional 2 conditions upon residential storage than those currently imposed by Subtitle 27 of the Prince 3 George's County Code (the "Zoning Ordinance"). 4 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's 5 County, Maryland, sitting as the District Council for that part of the Maryland-Washington 6 Regional District in Prince George's County, Maryland, that Ordinance O-3-06 of the City of 7 Bowie, as represented in Attachment A to this Resolution, be and is hereby approved.
