BILL

AN ACT concerning

The Creation of a New Capital Project

For the purpose of adding the Stadium Infrastructure Improvements, a new capital project, to the Approved Fiscal Year 1997 Capital Budget by transferring appropriations in the amount of \$12,500,000 from the Contingency Fund.

WHEREAS, pursuant to the provisions of Section 818 of the Charter for Prince George's County, Maryland, the County Council may authorize, by legislative act, upon the request of the County Executive, interproject transfers of appropriations between capital projects in the Approved Capital Budget; and

WHEREAS, under the provisions of Section 824 of the Charter for Prince George's County, Maryland, the County Council may, upon receipt of a recommendation in writing from the County Executive, after public hearing and with the affirmative vote of two-thirds of its members, amend the Capital Budget in accordance with such recommendation, without increasing the total amount of appropriations therefore; and

WHEREAS, the County Executive recommends the creation of a new capital project, the Stadium Infrastructure Improvements (FQ667443); and

WHEREAS, the County Executive recommends that appropriations can be transferred from the Contingency Fund; now, therefore,

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that the Fiscal Year 1997 Approved Capital Budget is hereby amended, as shown on Appendices A, B, and C, attached hereto, to provide for the creation of a new capital project, the Stadium Infrastructure Improvements, and appropriations for that purpose are transferred as follows:
