ORDER OF DISMISSAL

On or about April 6, 2021, applicant filed a written request to withdraw contested applications for Special Exception 4816 and authorization for issuance of permits to build in planned right-of-way. The request, as revised, was received after public release of Technical Staff Report and transmittal of applications to District Council. Applicant's Request to Withdraw Applications, 4/6/2021, 4/8/2021.

The request, as revised, to withdraw application to authorize issuance of permits to build in planned right-of-way, pursuant to PGCC § 27-299(a) and (e), signed by owners of record, applicant and authorized representatives, for two (2) pylon signs, 22 parking spaces, free air station, five (5) multi dispenser gasoline pumps with canopy, large vehicle parking areas, required landscaping, and stormwater management facility, in conjunction with Special Exception 4816, to construct a Gas Station with an associated Food or Beverage Store, on approximately 2.94 acres of land in the C-S-C (Commercial Shopping Center) Zone, located on the west side of MD 210 (Indian Head Highway), in the southwest quadrant of its intersection with MD 375 (Livingston Road), also identified as 15808 and 15812 Livingston Road, 100 Biddle Road, and 16001 Indian Head Highway, Accokeek, Maryland, Councilmanic District 9, is hereby GRANTED, subject to reapplication provisions of PGCC § 27-300.

Authorization to Build in Planned
Right-of-Way

PGCC § 27-300 provides that [n]o new Special Exception application for the same use may be filed on the same land until two (2) years have elapsed after final action (including appellate review) on a previous application. After two (2) applications for the same use on the same land have been acted upon, a period of four (4) years must elapse before another application for the same use on the same land may be filed.
