Transportation, Housing and Environment Committee October 3rd, 2013

Committee Vote: Favorable with amendments 5-0 (In favor: Council Members Campos, Davis, Olson, Toles and Turner)

The Legislative Officer provided a summary of CR-61-2013, referrals, and comments were received from the public at the public hearing held on September 10th.

Larry Coffman, Deputy Director, and Marilyn Ryback, Recycling Division, DER, provided additional information to the Committee in support of CR-61-2013 and in support for Amendment #1. Brad Frome, Office of the County Executive, provided testimony in support of the resolution.

Amendment #1 adds the Cedarville Organic Recycling Center in Brandywine, MD to the section for facilities added to the Ten Year Solid Waste Management Plan. Council Member Franklin offered support for Amendment #1. Amendment #1 was offered by Council Member Davis, seconded by Council Member Toles and was favorable by a vote of 5-0. It is reflected in Draft 2 of CR-61-2013.

The Office of Law indicated that CR-61-2013 was in proper legislative form with no legal impediment to its enactment.

The Office of Audits and Investigation indicated there will not have and adverse fiscal impact on the County as a result of adopting CR-61-2013.

September 19th, 2013 – Held in Committee

Council staff provided a summary of proposed Draft 2 of CR-61-2013. This resolution adopts the Prince Georges County's FY 2012-2022 Comprehensive Ten Year Solid Waste Management Plan (Plan) pursuant to Title 9, Subtitle 5 of the Environment Article of the Annotated Code of Maryland. This Plan is designed to respond to State and local requirements by setting forth systematic administration of activities and programs capable of meeting solid waste acceptance and disposal need over the next ten years.

Adam Ortiz, Director, and Robert Reading, Waste Management Division, DER, provided testimony in support of CR-61-2013 and answered questions from the Committee members.

CR-61-2013 was held in Committee for additional review.
