This Bill provides for the establishment of a Compensation Review Commission and for the appointment of its members. Section 308 and Section 406 of the Charter of Prince George’s County, Maryland provide for the appointment of a compensation review commission by the Council and County Executive. Section 10-302, Local Government I Article, Annotated Code of Maryland provides that by ordinance, a county may establish a commission to recommend compensation and allowances for members of the county legislative body. Section 10-303, Local Government I Article, Annotated Code of Maryland provides that the county may set the qualifications, term of office, and compensation for the County Executive.

The 2025-2026 Compensation Review Commission shall consist of the following seven citizens: Gloria G. Lawlah, Maurice Simpson, Jr., Steven L. Taylor, appointed by the County Council, and L.
