BILL

1 AN ACT concerning

2 A Supplementary Appropriation

3 For the purpose of appropriating to the General Fund revenue in excess of budget estimates to
4 provide funds for costs that were not anticipated in the Approved Fiscal Year 2000-2001 budget.

5 WHEREAS, CB-33-2000, as amended by CB-43-2001 and CB-44-2001 adopted and
6 enacted the Annual Budget and Appropriation Ordinance of Prince George's County for Fiscal
7 Year 2000-2001, which set forth the amount of appropriations and revenue estimates, said
8 appropriation and revenue estimates to be adjusted as hereinafter set forth; and

9 WHEREAS, pursuant to Section 819 of the Charter for Prince George's County, Maryland,
10 the County Council may, upon recommendation of the County Executive, make additional or
11 supplementary appropriations from revenue received from anticipated sources but in excess of
12 budget estimates therefor, from revenue received from sources not anticipated in the budget for
13 the current year and from any prior year available and uncommitted fund balances; and

14 WHEREAS, the Board of Education requires additional appropriations as provided herein,
15 and certain additional revenues have been identified; now, therefore,

16 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
17 Maryland, that the following adjustments to revenue estimates for the Fiscal Year 2000-2001 as
18 expressed in CB-33-2000, as amended, are made:
