PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT Date: 7/19/01

Committee Vote: Favorable, 5-0, (In favor: Councilmembers Bailey, Estepp, Maloney, Scott and Shapiro).

This bill will amend the Classification Plan assigning certain existing classes of work to the bargaining unit represented by the Deputy Sheriffs' Association of Prince George's County, Inc., (Civilian Units).

This amendment was approved by the County's Public Employee Relations Board on December 22, 2000.

The assigning of the Administrative Assistant I - III (Z-18, Z-21 and Z-24) classes of work to the

bargaining unit are retroactive to December 20, 2000.

The assigning of the Investigation I and II (Z-18 and Z-21) classes of work to the bargaining unit are retroactive to July 1, 2001.

There may be some negative fiscal impact on the County in the amount of \$15,000 as a result of enacting CB-56-2001. This amount is related to the conversion of approximately 8-13 General Schedule positions in the Sheriff's Department to Z-Schedule positions (Deputy Sheriff's Civilians).

BACKGROUND INFORMATION/FISCAL IMPACT (Includes reason for proposal, as well as any unique statutory requirements)

The Classification Plan is being amended for the purpose of assigning certain existing classes of work to the bargaining unit represented by the Deputy Sheriff's Association of Prince George's County, Inc. (Civilian Units). This amendment is in accord with the Amendment of Certification of Representation issued by the Prince George's County Public Employee Relations Board on December 22, 2000. This legislation also accompanies the Collective Bargaining Agreement between Prince George's County, Maryland and the Deputy Sheriff's Association of Prince George's County, Inc. (Civilian Units). The fiscal impact will be provided by the Office of Management and Budget.
