## A RESOLUTION concerning

## **Bonus Payments**

For the purpose of amending the Salary Plan of the County to reflect bonus payments for certain employees who are represented for purposes of collective bargaining.

WHEREAS, pursuant to Section 903 of Article IX of the Prince George's County Charter and Section 16-125(a) of the Prince George's County Code, amendments to the County's Salary Plan are to be submitted to the County Council in resolution form; and

WHEREAS, the County Executive has submitted and recommended an amendment to the County's Salary Plan to reflect the terms of certain recently negotiated collective bargaining agreements which provide for bonus payments in fiscal year 1998 to employees covered by those agreements; and

WHEREAS, the Salary Plan must at this time be amended in order to implement such bonus payments;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that Salary Schedules A (AFSCME 2462), B, C, H, and Z are amended by the addition of the following:

Employees covered by this Salary Schedule will receive a one-time, non-base, lump-sum bonus payment of One Thousand Dollars (\$1,000.00) on the second pay date in December, 1997. Said payment shall not be made part of the base salary schedule and shall be considered in the nature of premium pay for purposes of retirement and other benefit computations.

BE IT FURTHER RESOLVED that Salary Schedules A (AFSCME 2735) and I are

amended by the addition of the following:

Employees covered by this Salary Schedule with normal work hours during a pay period

equal to fifty (50) or more hours will receive a one-time, non-base, lump-sum bonus payment

of One Thousand Dollars (\$1,000) on the second pay date in December, 1997. Employees

covered by this Salary Schedule with normal work hours during a pay period equal to less

than fifty (50) hours will receive a one-time, non-base, lump-sum bonus payment of Five

Hundred Dollars (\$500). Said payment shall not be made part of the base salary schedule and

shall be considered in the nature of premium pay for purposes of retirement and other benefit

computations.

BE IT FURTHER RESOLVED that Salary Schedule X is amended by the addition of the

following:

Employees covered by this Salary Schedule will receive a one-time, non-base, lump-sum

bonus payment of Four Hundred Dollars (\$400.00) on the second pay date in December, 1997.

Said payment shall not be made part of the base salary schedule and shall be considered in the

nature of premium pay for purposes of retirement and other benefit computations.
