Mr. David C. Brosch, a resident of University Park, has been an environmental advocate for decades. He is adept at organizing networks of citizens, advocates, companies, and public agency personnel to promote and advance environmental concerns. Mr. Brosch is a member of the Maryland Sierra Club and served for four non-consecutive terms on the University Park Town Council. He possesses a Bachelor of Arts degree from Loras College; a Bachelor of Science degree from the University of Maryland, College Park; and a Master of Arts degree from Howard University.

Mr. Mouhaman S. Kola, a resident of Suitland, is an Environmental Protection Specialist with the Department of Energy and Environment. He advocates and volunteers his time to educate others on the benefits of recycling and responsible waste management practices and is a Licensed Environmental Health Specialist. A member of the National Association for Environmental Management, he holds both a Bachelor of Science degree and a Master of Science degree in Environmental Management from the University of Maryland University College (now University of Maryland Global Campus).

Mr. Jonathan P. Madagu, a resident of Kettering, has more than thirty-five (35) years of experience in civil engineering, code enforcement, zoning, and economic development. He possesses thorough knowledge of water and sewer projects and water resources gained while employed by the Washington Suburban Sanitary Commission (WSSC). Mr. Madagu is a member and chaired the Chesapeake Section American Water Works Association (CSAWWA) Board of Directors. He received his Bachelor of Science degree in Civil Engineering from Howard University and his Master of Business Administration, Master of Science degrees in Management and a Graduate Certificate in Project Management from the University of Maryland, University College.
