Staff summarized the purpose of the resolution. CR-74-2006 amends the Washington Suburban Sanitary Commission (WSSC) Fiscal Years 2007-2012 Capital Improvement Program (CIP) for Prince George's County for Water and Sewerage. The Resolution calls for an addition of a sewer main to serve the Karington subdivision.

Council Member Peters spoke in full support of CR-74-2006 and asked for a favorable consideration by the Committee on the legislation. The WSSC representative indicated that the developer will fund the project and no budget supplement will be required.

The Office of Law determined that it is in proper legislative form.

The County Executive staff provided no comment.

BACKGROUND INFORMATION/FISCAL IMPACT:

The Karington Subdivision Sewer is a 5,400 feet of 15 and 18-inch sewer main to serve the Karington subdivision. The Karington Subdivision is a mixed-use development project on line which currently has a major sewer trunk main installed on site. Capacity: 1.7 to 2.87 MGD; Service Area: Mitchellville & Vicinity; Population: 2,102; Status: P-O%; Estimated Total Project Cost: \$801, 000. Estimated completion date is developer dependent. No WSSC rate supported debt will be used for this project.
