RESOLUTION

1 A RESOLUTION concerning

2 Housing and Community Development

3 Annual Action Plan: FY 2011

4 For the purpose of approving the reprogramming of \$1,300,000 in HOME Investment

5 Partnership funds (“HOME”) from the FY 2004, FY 2005, FY 2006, FY 2008, and FY 2009

6 Annual Action Plans to the FY 2011 Annual Action Plan for the Rainier Manor project.

7 WHEREAS, CR-27-2010 amended the FY 2011 Annual Action Plan (i.e., HOME Program
8 Year 18) to include the Rainier Manor project (the “Project”), its estimated cost of completion,
9 and its funding sources; and

10 WHEREAS, Section 15A-105(a)(2) of the County Code requires that annual action plans
11 include the estimated cost of projects, the total cost to bring them to completion, and an
12 identification of the sources of funds; and

13 WHEREAS, the Project, as described in Attachment “A”, requires additional funding for
14 completion; and

15 WHEREAS, Attachment “B” describes the projects from HOME Program Years 12, 13, 14,
16 16, and 17 (i.e., Annual Action Plans FY 2004, FY 2005, FY 2006, FY 2008, and FY 2009) with
17 \$1,300,000 in HOME funds needing to be reprogrammed; and

18 WHEREAS, the County Executive recommends the reprogramming of \$1,300,000 in
19 HOME funds to the Project.

1 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
2 County, Maryland, that the FY 2011 Annual Action Plan is hereby amended to reprogram and
3 reallocate \$1,300,000 in HOME funding to the Project as described in Attachments "A" and
4 "B".

5 BE IT FURTHER RESOLVED that upon adoption of this Resolution, it shall be
6 transmitted to the County Executive by the Clerk of the Council to submit the amended Annual
7 Action Plans to the U.S. Department of Housing and Urban Development.

8 BE IT FURTHER RESOLVED that this resolution shall become effective as of the date of
9 its adoption.
