BE IT ENACTED by the County Council of Prince George's County, 4 Maryland, that the Prince George's County portion of the Maryland-National Capital Park and 5 Planning Commission's Capital Improvement Program for Fiscal Years 2000-2005, as adopted 6 by CB-28-1999, is hereby amended to include the project as shown in Exhibit A attached hereto 7 and made a part hereof. 8 SECTION 2. BE IT FURTHER ENACTED that the Fiscal Year 1999-2000 Capital Budget 9 of the Maryland-National Capital Park and Planning Commission, as adopted by CB-27-1999, Appendix B, is hereby amended to increase the amount in the Commission's Capital Budget by 10 11 \$5.5 million in accordance with the following schedule: 12 13 Project Name **Description** 14 **Junior Tennis Champions** Construction of twelve (12) 15 Center indoor and fifteen (15) outdoor 16 tennis courts. 17 SECTION 3. BE IT FURTHER ENACTED that the funding for this project shall be 18 19 derived from a developer contribution. 20 SECTION 4. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) 21 calendar days after it becomes law
