WHEREAS	S, Section 15-103(b) of the Land Use Article, Annotated Code of Maryland, sets	
forth the procedures for appointment of commissioners to the Maryland-National Capital Park		
and Planning Co	mmission in Prince George's County; and	
WHEREAS	S, Section 15-103(b) requires that the County Council hold a public hearing on	
an appointment t	o the Commission not later than twenty (20) days, and may approve or	
disapprove the ap	opointment within thirty (30) days after the County Executive submits the name	
of the appointee	to the County Council; and	
WHEREAS	S, Section 15-103(b)(4) requires that the resolution for each appointment	
describe the resu	lting geographic distribution and provide appropriate explanations; and	
WHEREAS	, the County Executive has duly nominated John P. Shoaff, a resident of	
University Park,	to serve as commissioner of the Maryland-National Capital Park and Planning	
Commission of t	he Prince George's County Planning Board; and	
WHEREAS	S, a public hearing on the appointment of John P. Shoaff to the Commission has	
been held before	the County Council; and	

1	WHEREAS, the remaining four (4) members of the Commission from Prince George's
2	County are residents of Bowie, Temple Hills, Fort Washington, and Mitchellville, respectively.
3	NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
4	County, Maryland, sitting as the District Council for that part of the Maryland-Washington
5	Regional District in Prince George's County, Maryland, that, as a result of appointment of John
6	P. Shoaff as commissioner of the Maryland-National Capital Park and Planning Commission,
7	there continues to be a reasonable geographic distribution with respect to the places of residence
8	of the members of the Commission from Prince George's County.
9	BE IT FURTHER RESOLVED that appointment of John P. Shoaff as a commissioner of
10	the Maryland-National Capital Park and Planning Commission for a term expiring June 15,
11	2018, be and the same is hereby approved.
