Item: César Chávez School Parents Opposing DSP-22001 McDonald's Ager Road

Dear Ms. Brown,

We are writing once again as a community of concerned parents who strongly oppose McDonald's plan to bring a drive-through, fast-food restaurant to our school's neighborhood. We wish to express our continued concern for the harm that this McDonald's poses to our children, and to reiterate reasons for our strong objection. This letter is signed by elected officers of our Parent Teacher Organization (PTO) for the 2025/2026 school year, as well as parents leading our PTO Advocacy Committee. We represent a community of parents and families who are deeply invested in the health and well-being of our children. .

Our children attend César Chávez Dual Spanish Immersion Elementary School (CCDSI), which is located at 6609 Riggs Rd. Our school attracts families from a large swathe of the county who value a bilingual, bicultural education. Most of our children commute via bus or car and must go through the major intersection where McDonald's is proposed, 0.3 miles to the north of school.

In response to this threat, a growing number of parents and staff have responded to our efforts to expand awareness of McDonald's plan to come to our neighborhood. Earlier this year, we distributed a letter outlining our community's collective opposition to the drive-through McDonald's on Ager Rd, in English and Spanish. Via messaging apps and email lists, the CCSDI community was invited to sign on to endorse the comments. In a very short period of time, 144 CCDSI parents and staff quickly responded to sign the petition between 3/23/25 and 3/26/25. We quickly pulled together the letter and petition for the special hearing on 4/1/25. In the fall of 2024 our PTO established an Advocacy Committee. We have followed this issue and given updates at monthly PTO meetings. As the news of this McDonald's has spread, parents have repeatedly responded with surprise and outrage that this project continues despite repeatedly voiced concerns.

This McDonald's **will** bring increased harm to our children and families. We are particularly disappointed that the Planning Board has not required a thorough Health Impact Study that would examine the concerns we have raised. Since the Planning Board is not acting to protect our community with due diligence, we urge the County Council to take action to prevent this unwanted McDonald's drive-through. Our reasons for opposition remain strong. Below is a brief summary of these reasons.

Air Quality Affecting Children's Developing Lungs: Asthma is a major health concern affecting children in our county. Idling vehicles emit harmful pollutants which are linked to respiratory illnesses and cancer. Studies have demonstrated that children attending schools near high-traffic areas face a 45% higher risk of developing asthma. An estimated 13.85% of PG county children are diagnosed with asthma, higher than the national rate of 8%. Children's developing lungs are

particularly susceptible to these toxins, and increased exposure leads to more severe asthma attacks and long-term respiratory complications. Construction of McDonald's in this congested area would significantly worsen air quality due to increased traffic and vehicle idling, directly endangering the health of our children, and especially those with asthma.

Traffic Hazards and Pedestrian Safety: Parents and administrators actively advocate for our children's safe arrival and departure from school. The McDonald's site is on a perilous segment of East-West Hwy (MD-410) at the intersection with Riggs Road, which is just to the north of our school. This one-mile corridor has been ranked the 5th most hazardous in Prince George's County according to data from Vision Zero. The addition of a McDonald's drive-through in such close proximity to our school will increase traffic congestion and ultimately endanger more young lives. By introducing hundreds more cars, exiting and entering traffic from Ager, just where Ager merges with East-West Hwy and intersects with Riggs Rd., this McDonald's **will** cause harm to our children commuting to and from school, for years to come.

Environmental and Social Impacts: McDonald's' plans would destroy established trees, add pavement, generate unmitigated stormwater, and introduce an immense amount of waste in our school's immediate surroundings. In addition, it will worsen the existing urban heat island. We value the remaining trees in this part of our immediate community, which include native species, and implore you to see that they are preserved.

McDonald's has a poor record of environmental responsibility, earning negative impact scores for responsible consumption and production, due to high global carbon dioxide emissions, water consumption, and food packaging waste (greendigest.co ref). McDonald's wages are notoriously low, despite being the largest fast-food corporation in the world. Nationally, McDonald's employees rely on food assistance (SNAP) and health subsidies (Medicaid) since McDonald's does not provide living wages to large proportions of its employees. There are already too many McDonald's restaurants in our community.

For the sake of our youngest citizens, we urge you to prevent McDonald's from being constructed. Rather, please model values of stewardship and social responsibility for our children by preventing the construction of this business, supporting instead the locally-owned, Latino restaurant that exists on the site.

Nutrition Inequities: This drive-through would be within one of the County's Healthy Food Priority Areas (HFPA), designated because of a lack of access to healthy food. Areas like this have been described as "food swamps," that have a high density of establishments selling fast food and junk food. There are **already 15 McDonald's within a 10-mile radius of this site**, with seven more proposed nearby. Food swamps are associated with increased obesity rates and associated poorer health outcomes, and this "food swamp effect" is even stronger in counties with greater income inequality. McDonald's menu is made up of high caloric, high sugar items. Rather than an additional McDonald's, we need to bring healthier food retailers to our diverse community.

We remain deeply concerned about the detrimental impacts of this project to our children's health and development, and to our greater community. We urge the County Council, please take action to disapprove DSP-22001, reverse the Prince George's County Planning Board's Approval of DSP-22001, and prevent the McDonald's corporation from building their drive-through at this intersection. Please ensure this letter is included in the public record for the hearing on October 6.

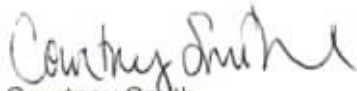

Dear Ms. Brown,

We are a community of concerned parents writing in response to the McDonald's plan to bring a drive-through, fast-food restaurant to our school's neighborhood. Our children attend César Chávez Dual Spanish Immersion Elementary School (CCDSI), which is located at 6609 Riggs Rd in Chillum, two blocks away from the proposed McDonald's site. Our elementary school attracts families from throughout the county who value a bilingual, bicultural educational setting for their young children. Admission to CCDSI is via lottery, with half of each incoming kindergarten class composed of students who primarily speak Spanish, and half English, at home.

We are deeply concerned about the detrimental impacts of this project to our children's health and development, and to our greater community. We respectfully urge the District Council to disapprove the McDonald's on East-West Hwy (Detailed Site Plan (DSP) 22001). Our reasons for concern include increased air pollution, traffic hazards, and destruction of forest and tree canopy, and are detailed below.

Air Quality Affecting Children's Developing Lungs: Asthma is a major health concern affecting children in our county. Idling vehicles emit harmful pollutants which are linked to respiratory illnesses and cancer. Studies have demonstrated that children attending schools near high-traffic areas face a 45% higher risk of developing asthma. An estimated 13.85% of PG county children are diagnosed with asthma, higher than the national rate of 8%. Children's developing lungs are particularly susceptible to these toxins, and increased exposure can lead to severe asthma attacks and long-term respiratory complications. Construction of McDonald's in this congested area would significantly worsen air quality due to increased traffic and vehicle idling, directly endangering the health of our children, and especially those with asthma.

Traffic Hazards and Pedestrian Safety: Children and parents commute to CCDSI via car, bus, bicycle, and on foot from a large swath of the county. Parents and administrators actively advocate for our children's safe arrival and departure from school. This year we have secured crossing guard presence, but there is no infrastructure beyond a crosswalk to support safe crossing of Riggs Road. Children must cross six lanes of speeding cars during rush hour. Requests from our administration to install a traffic light have not been granted.

The McDonald's site is on a perilous segment of East-West Hwy (MD-410) at the intersection with Riggs Road, which is just to the north of our school. This one-mile corridor has been ranked the 5th most hazardous in Prince George's County according to data from Vision Zero, a collaboration with MDOT State Highway Administration and MD Highway Safety Office. The addition of a drive-through McDonald's in such close proximity to our school will increase traffic congestion and ultimately endanger young lives.

Environmental and Social Impacts: McDonald's' plans would destroy more than one acre of forest and tree canopy, add pavement, and promises to worsen the existing urban heat island. Destruction of these trees will generate more unmitigated stormwater, contributing to contamination of our waterways. The McDonald's project does not align with county priorities for woodland and wildlife conservation. We value the remaining trees in this part of our immediate community, which include native species, and implore you to see that they are preserved.

McDonald's has a poor record of environmental responsibility, earning negative impact scores for responsible consumption and production, due to high global carbon dioxide emissions, water consumption, and food packaging waste ([greendigest.co](https://www.greenpeace.org/usa/press-releases/mcdonalds-environmental-impact)). McDonald's wages are notoriously low, despite being the largest fast-food corporation in the world. Nationally, McDonald's employees rely on food assistance (SNAP) and health subsidies (Medicaid) since McDonald's does not provide living wages to large proportions of its employees. There are already too many McDonald's restaurants in our community.

For the sake of our youngest citizens, we urge you to prevent McDonald's from being constructed. This McDonald's would needlessly destroy valued trees and tree canopy, add to waterway contamination and urban heat problems, and sustain ongoing lack of opportunities for economic mobility in our area. Rather, please model values of stewardship and social responsibility for our children by preventing the construction of this business, supporting instead the locally-owned, Latino restaurant that exists on the site.

Nutrition Inequities: This drive-through would be within one of the County's Healthy Food Priority Areas (HFPA), designated because of a lack of access to healthy food. Areas like this have been described as "food swamps," that have a high density of establishments selling fast food and junk food. There are already 15 McDonald's within a 10-mile radius of this site, with seven more proposed nearby. Food swamps are associated with increased obesity rates and associated poorer health outcomes, and this "food swamp effect" is even stronger in counties with greater income inequality (Cooksey-Stowers et al., 2017). McDonald's menu is made up of high caloric, high sodium, and high sugar items. Rather than an additional McDonald's, we need to bring healthier food retailers to our diverse community.

Please disapprove the construction of this McDonald's (DSP-22001) in our community and ensure that my letter is included in the public record for this case. Many of our parents who

oppose this McDonald's have expressed that they were not aware it would help our cause to register as a Person of Record on this issue, or that once they became aware, the deadline had passed.

Artículo: Miembros de la comunidad de César Chávez se oponen al McDonald's en la East-West Hwy, DSP 22001

Estimada Ms. Brown:

Somos una comunidad de padres preocupados que escriben en respuesta al plan de McDonald's de construir un restaurante de comida rápida con drive-thru al vecindario de nuestra escuela. Nuestros hijos asisten a la Escuela Primaria César Chávez de Doble Inmersión en Español (CCDSI), ubicada en 6609 Riggs Rd en Chillum, a dos cuadras del sitio propuesto para McDonald's. Nuestra escuela primaria atrae a familias de todo el condado que valoran un entorno educativo bilingüe y bicultural para sus hijos pequeños. La admisión a CCDSI se realiza por sorteo, y la mitad de cada clase de kínder entrante está compuesta por estudiantes que hablan principalmente español, y la otra mitad inglés.

Nos preocupan profundamente los efectos perjudiciales de este proyecto para la salud y el desarrollo de nuestros niños, así como para nuestra comunidad en general. Instamos respetuosamente al Consejo de Distrito a desaprobamos el McDonald's en la East-West Hwy (DSP 22001). Nuestras preocupaciones incluyen el aumento de la contaminación atmosférica, los peligros para el tráfico, la destrucción del bosque y la cubierta arbórea, y se detallan a continuación.

La calidad del aire afecta el desarrollo pulmonar de los niños: El asma es un importante problema de salud infantil en nuestro condado. Los vehículos dejados en reposo emiten contaminantes nocivos relacionados con enfermedades respiratorias y cáncer. Estudios han demostrado que los niños que asisten a escuelas cercanas a zonas de alto tráfico tienen un 45% más de riesgo de desarrollar asma. Se estima que el 14% de los niños del condado de PG son diagnosticados con asma, un porcentaje superior a la nacional del 8%. Los pulmones en desarrollo de los niños son particularmente susceptibles a estas toxinas, y una mayor exposición puede provocar ataques de asma graves y complicaciones respiratorias a largo plazo. La construcción de McDonald's en esta zona congestionada empeoraría significativamente la calidad del aire debido al aumento del tráfico y el ralentí de los vehículos, lo que pondría en peligro la salud de nuestros niños, especialmente de aquellos con asma.

Peligros de tráfico y seguridad Peatonal: Niños y padres viajan a CCDSI en coche, autobús, bicicleta y a pie desde diferentes partes del condado. Padres y administradores abogan activamente por la llegada y salida segura de nuestros hijos de la escuela. Este año hemos asegurado la presencia de guardias de cruce, pero no hay infraestructura más allá de un cruce peatonal para facilitar el cruce seguro de Riggs Road. Los niños deben cruzar seis

carriles de vehículos durante las horas punta. Las solicitudes de nuestra administración para instalar un semáforo no han sido atendidas.

El McDonald's se encontraría en un tramo peligroso de la East-West Hwy (MD-410), en la intersección con Riggs Road, justo al norte de nuestra escuela. Este corredor de una milla ha sido clasificado como el quinto más peligroso del Condado de Prince George, según datos de Visión Zero, una colaboración entre la Administración Estatal de Carreteras del Departamento de Transporte de Maryland (MDOT) y la Oficina de Seguridad Vial de Maryland. La construcción de un McDonald's con drive-thru tan cerca de nuestra escuela aumentará la congestión vehicular y, en última instancia, pondrá en peligro la vida de niños.

Impactos ambientales y sociales: Los planes de McDonald's destruirían más de una hectárea de bosque y dosel arbóreo, añadirían pavimento y prometen agravar la isla de calor urbana existente. La destrucción de estos árboles generará más aguas pluviales sin mitigar, lo que contribuirá a la contaminación de nuestras vías fluviales. El proyecto de McDonald's no se alinea con las prioridades del condado para la conservación de los bosques y el dosel arbóreo. Valoramos los árboles que quedan en nuestra comunidad, que incluyen especies nativas, y les rogamos que se aseguren de preservarlos.

McDonald's tiene un historial deficiente de responsabilidad ambiental, con evaluaciones negativas por consumo y producción responsables, debido a las altas emisiones globales de dióxido de carbono, el consumo de agua, y el desperdicio de envases de alimentos (greendigest.co). Los salarios de McDonald's son notoriamente bajos, a pesar de ser la empresa de comida rápida más grande del mundo. A nivel nacional, los empleados de McDonald's dependen de la asistencia alimentaria (SNAP) y de los subsidios de salud (Medicaid), ya que McDonald's no proporciona salarios dignos a una gran proporción de sus empleados. Ya hay demasiados restaurantes McDonald's en nuestra comunidad.

Por el bienestar de nuestros jóvenes, les instamos a impedir la construcción de McDonald's. Este McDonald's destruiría innecesariamente árboles valiosos, agravaría la contaminación de las vías fluviales y los problemas de calor urbano, y perpetuaría la falta de oportunidades de movilidad económica en nuestra zona. En lugar de eso, les rogamos que demuestren valores de responsabilidad social para nuestros niños, impidiendo la construcción de este negocio y apoyando en su lugar el restaurante latino de propiedad local que existe en el lugar.

Desigualdades nutricionales: Este autoservicio se ubicaría dentro de una de las Áreas Prioritarias de Alimentos Saludables del Condado, designadas debido a la falta de acceso a alimentos saludables. Áreas como esta se han descrito como "pantanos de comida", con una alta densidad de establecimientos que venden comida rápida y chatarra. Ya hay 15 McDonald's en un radio de 10 millas de este sitio, y se han propuesto siete más en las cercanías. Los pantanos de comida se asocian con mayores tasas de obesidad y peores resultados de salud, y este "efecto pantano de comida" es aún más pronunciado en los condados con mayor desigualdad de ingresos (Cooksey-Stowers et al., 2017). El menú de McDonald's se compone de productos con alto contenido calórico, de sodio y de azúcar. En lugar de un McDonald's adicional, necesitamos traer tiendas de alimentos más saludables a nuestra diversa comunidad.

Por favor, desapruebe la construcción de este McDonald's (DSP-22001) en nuestra comunidad y asegúrese de que mi carta se incluya en el registro público de este caso. Muchos de nuestros padres que se oponen a este McDonald's han expresado que no sabían que registrarse como Persona de Registro en este asunto contribuiría a nuestra causa, o que, una vez que se enteraron, la fecha límite ya había vencido.
