Built to LEED-Silver certification standards and to accommodate up to 175 buses








# New Rail Heavy Repair and Overhaul Facility


May 2019 action by WMATA Board to approve public hearing report and authorize acquisition of properties.

Facility will accommodate new Scheduled Maintenance System for railcars, improving efficiency, fleet reliability and on-time performance.

New 275,000 SF office building includes 12,000 SF of retail on Metro's joint development site.


Metro's new office building will bring more employment to New Carrollton.

# Platform Improvement Project - Summer 2020

- Greenbelt, College Park, Prince George's Plaza and West Hyattsville will close during Summer 2020
- Final dates depend upon contractor response to RFP
- Full shutdown anticipated for Memorial Day weekend through Labor Day of 2020
- Single Tracking planned between Greenbelt and College Park (April 11 – May 22, 2020)
  - Green Line w/ 8-minute headways
  - Yellow Line terminates at Fort Totten





### Sustainability Initiatives

 318 new trees planted at 3 stations in the County in partnership with the Anacostia Watershed Society



- Solar canopies anticipated at Southern Avenue, Naylor Road and Cheverly
- RFP for solar developer to be released July and awarded by Dec 2019





### New Carrollton Joint Development





- March 2019:
  - 210,000 square foot office opened by Kaiser-Permanente
  - New internal road network completed on southeast side of Metro Station
- June 2019: Closing on 282-unit multifamily residential phase
- Development of Metro's office building may be accompanied by development of two additional buildings adjacent to it




# College Park Joint Development

- Jan 2018: Executed Joint
   Development Agreement with
   Gilbane Development Company
- 440-unit residential building with ground floor retail
- "Brooks Parcel" will be green space
- Coordination with Purple Line
- 2019/2020: Ground-breaking

- Improve plaza at station entrance
- Unfunded for design & construction

- No replacement of Metro parking (parking available at Addison Road Metro)
