 <sup>(</sup>A) The church is located in an existing freestanding building not exceeding two stories in heights;
 (B) If the building in which the church is located contains other uses, a separate entry to the church must be provided for its use; and

<sup>(</sup>C) At the time of issuance of the initial use and occupancy permit, the church shall be located within 1,000 feet of another existing church.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect forty-five (45) calendar days after its adoption.
