**RESOLUTION**

A RESOLUTION concerning

The Washington Suburban Sanitary Commission Fiscal Years

1998-2003 Capital Improvements Program and Fiscal Year 1998

Capital Budget for Prince George's County for Water and Sewerage

FOR the purpose of adopting with amendments the WSSC Fiscal Years 1998-2003 Capital Improvements Program and Fiscal Year 1998 Capital Budget for Water and Sewerage.

WHEREAS, Article 29, Section 7-104 of the Annotated Code of Maryland requires the Washington Suburban Sanitary Commission (hereinafter "WSSC") to submit on or before October 1 of each year a Capital Improvements Program to the County Executive for Prince George's County; and

WHEREAS, Article 29, Section 7-105 of the Annotated Code of Maryland requires the County Executive to transmit said program together with comments, recommendations, and suggested amendments to the Council; and

WHEREAS, this Capital Improvements Program must contain, at a minimum, major projects as that term is defined in Article 29, Section 7-101, including water and sewerage projects; and

WHEREAS, this WSSC Capital Improvements Program is part of the Adopted County Comprehensive Ten Year Water and Sewerage Plan and contains projects to support water supply and sewerage system development as proposed in the plan; and

WHEREAS, the Montgomery County Council on October 15, 1996, by Resolution No. 13-693; and the Prince George's County Council on October 8, 1996, by Resolution No. CR-

53-1996, established the following spending control limits for the Fiscal Year 1998 Water and Sewer Capital Budget of the Washington Suburban Sanitary Commission:

New Water and Sewer Debt	\$ 64.5 Million
Water and Sewer Debt Service	\$141.7 Million; and

WHEREAS, in accordance with Section 1-204 of Article 29, Annotated Code of Maryland, the Washington Suburban Sanitary Commission did timely submit to the County Executives of Montgomery and Prince George's Counties the Proposed Capital and Operating Budgets as amended for the Fiscal Year 1998 and the record of the public hearing held by the Commission on the said Budgets; and

WHEREAS, the WSSC has delivered its Capital Improvements Program to the County Executive; and

WHEREAS, the County Executive has transmitted to the Council, the WSSC Capital Improvements Program, together with such comments as were deemed appropriate; and

WHEREAS, Article 29, Section 7-105 of the Annotated Code of Maryland further provides that after notice, the County Council shall approve, disapprove or modify the WSSC Capital Improvements Program provided that the WSSC is afforded an opportunity to comment on suggested modifications; and

WHEREAS, all other requirements of Title 7 of Article 29 of the Annotated Code of Maryland that concern final action by the Council on the WSSC Capital Improvements Program for Water and Sewerage and for Stormwater management have been met; now therefore

SECTION 1. BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the "Capital Improvements Program Fiscal Years 1998-2003 and the Capital Budget Fiscal Year 1998 for Water and Sewerage" as transmitted by the County Executive, is hereby adopted as amended by the attached Appendix 1.

SECTION 2. BE IT FURTHER RESOLVED by the County Council of Prince George's County, Maryland, that the Washington Suburban Sanitary Commission policy for Temporary CIP Facilities as shown in appendix 2 is hereby approved.
